



To keep you informed on what's happening at the State Capitol in response to COVID-19, we wanted to share with you the following updates.





On Wednesday, March 25, **Governor Gretchen Whitmer** issued one new executive order (hyperlinks below with all EOs):

• Executive Order 2020-22 – Extends the deadline to complete the canvass of the March 10 primary to April 24.

The state updated the **FAQs regarding Executive Order 2020-21**, which ordered the shelter in place. It clarifies that bottle return service is not considered critical infrastructure, despite being located in grocery stores, which remain open. Click here to read the FAQs.

The **Michigan Economic Development Corporation's** Pure Michigan Business Connect Program is expanding its free, online procurement platform by now including donations from suppliers capable of filling needs such as protection equipment, food, medical devices, paper products, and more. ## Description and Links to Governor Whitmer's Executive Orders Related to COVID-19:

While we have been sharing these executive orders with you as they were announced, the following is a complete list with links to each of the Executive Orders:

<u>EXECUTIVE ORDER 2020-4</u> - Declaration of a State of Emergency.

<u>EXECUTIVE ORDER 2020-7</u> - Temporary restrictions on entry into health care facilities,

residential care facilities, congregate care facilities, and juvenile justice facilities.

EXECUTIVE ORDER 2020-8 - Enhanced restrictions on price gouging.

<u>EXECUTIVE ORDER 2020-9</u> - Temporary restrictions on the use of places of public accommodation.

<u>EXECUTIVE ORDER 2020-10</u> - Temporary expansions in unemployment eligibility and cost-sharing.

<u>EXECUTIVE ORDER No. 2020 -11</u> - Temporary prohibition on large assemblages and events, along with temporary school closures.

EXECUTIVE ORDER 2020-12 - Enhanced support for deliveries.

<u>EXECUTIVE ORDER 2020-13</u> – Temporary enhancements to operational capacity and efficiency of health care facilities.

<u>EXECUTIVE ORDER 2020-14</u> - Temporary extension of deadline to redeem property for nonpayment of delinquent property taxes

<u>EXECUTIVE ORDER 2020-15</u> - Temporary authorization of remote participation in public meetings and hearings and temporary relief from monthly meeting requirements for school boards

<u>EXECUTIVE ORDER 2020-16</u> - Expanding childcare access during the COVID-19 emergency

<u>EXECUTIVE ORDER 2020-17</u> – Provides temporary restrictions on non-essential medical and dental procedures

EXECUTIVE ORDER 2020-18 - Enhances restrictions on price gouging

<u>EXECUTIVE ORDER 2020-19</u> – Provides a temporary prohibition against entry to premises for the purpose of removing or excluding a tenant or mobile homeowner from their home

<u>EXECUTIVE ORDER 2020- 20</u> – Extends the temporary restrictions on the use of public places of accommodations through April 13. The order adds hair, nail, and tanning salons to the list of restricted places.

EXECUTIVE ORDER 2020-21 – Temporary shelter in place for the state through April 13.

EXECUTIVE ORDER 2020-22 – Extends the deadline to complete the canvass of the March 10 primary to April 24.
