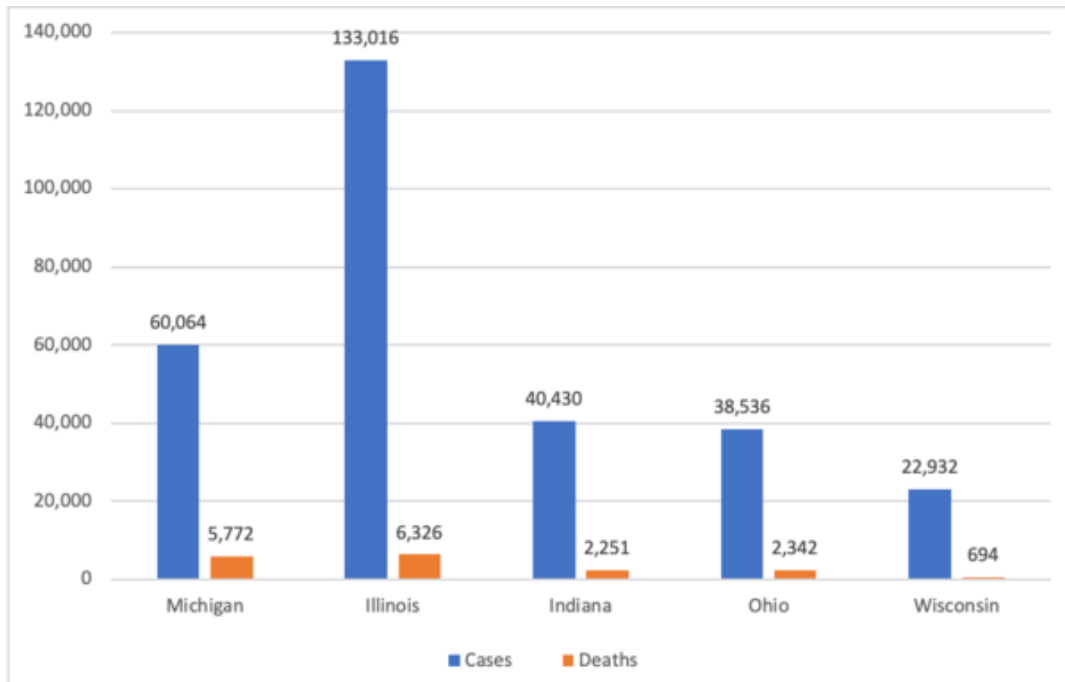

Governor Gretchen Whitmer issued one new Executive Order (hyperlinks below with recent EOs):

- **Executive Order 2020-122** - Beginning June 20, statute of limitations will return to normal calculation.



Statute of Limitations Returning to Normal

In the latest Executive Order, the Statute of Limitations will return to being calculated normally beginning on June 20. This rescinds prior Executive Orders that temporarily suspended certain timing requirements related to the commencement of civil and probate actions and proceedings. Once the E.O. goes into effect, statutes of limitations will have been tolled for 102 days. The newest order coincides with a Michigan Supreme Court Administrative Order.
