



Description and Links to Governor Whitmer's Executive Orders Related to COVID-19:

We are sharing executive orders with you as they are announced. A complete list with links to each of the Executive Orders is available here.

EXECUTIVE ORDER 2020-122 - Beginning June 20, statute of limitations will return to normal calculation.

EXECUTIVE ORDER 2020-120 - Lifts restrictions on overnight residential, travel, and troop camps beginning June 15.

EXECUTIVE ORDER 2020-119 - Temporarily suspends transfers into and from Department of Correction facilities unless jails adopt certain risk-reduction protocols.

EXECUTIVE ORDER 2020-118 - Extends the ban on evictions through June 30.

EXECUTIVE ORDER 2020-117 - Continues expanded access and capacity for child care services, giving priority to essential workforces through July 7.
