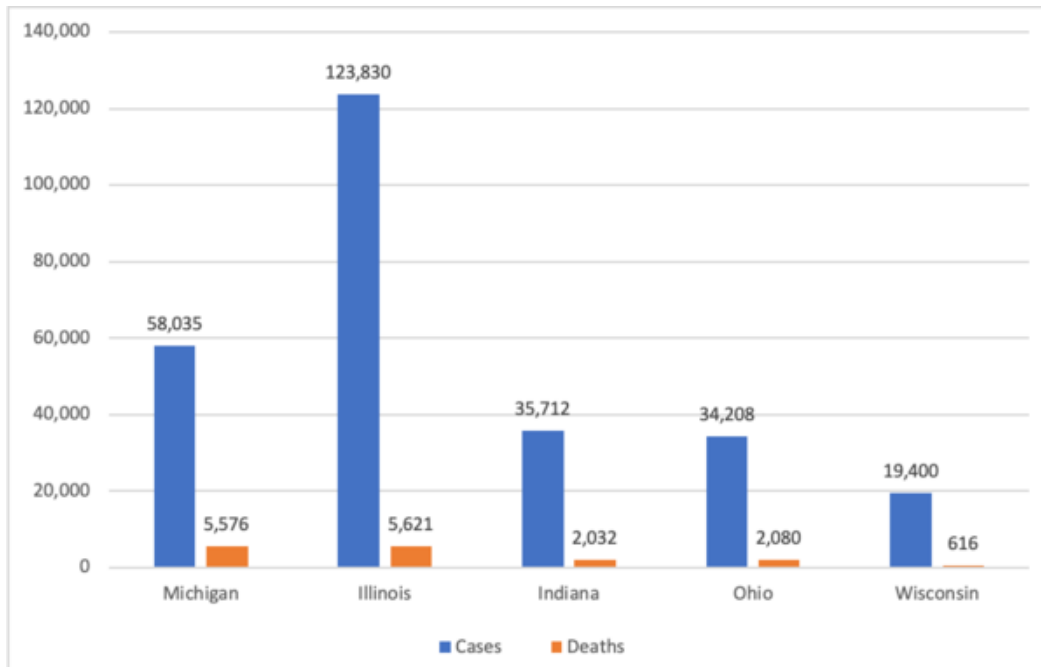

Appointments Made to COVID-19 Council

Governor Whitmer announced the appointments of 25 leaders in health care and education to the COVID-19 Return to School Advisory Council. The council was created through Executive Order and will work to identify the critical issues that must be addressed, provide input to inform the process of returning to school, and to ensure a smooth and safe transition back to school. The council will also include four members of the legislature; Senator Wayne Schmidt, Senator Dayna Polehanki, Representative Aaron Miller, and Representative Sheryl Kennedy. [EXECUTIVE ORDER 2020-122](#) - Rescinds Executive Orders on FOIA, hospital capacity, emergency medical services, and loosens restrictions on who can visit patients in certain health settings.

[EXECUTIVE ORDER 2020-111](#) - Requires owners and operators of employer-provided migrant housing to provide residents with the same safeguards businesses are required to provide workers under E.O. 2020-97 and additional requirements.

[EXECUTIVE ORDER 2020-110](#) - Rescinds the Safer at Home order, moves the entire state to Phase 4 of the MI Safe State Plan.

[EXECUTIVE ORDER 2020-109](#) - Extends the face mask requirement, the requirement for grocery stores and pharmacies to provide shopping time for vulnerable populations, and notification of employees when one employee has tested positive for the virus through June 12.

[EXECUTIVE ORDER 2020-108](#) - Maintains restrictions to health care and residential facilities through June 26.
