

## **Small Businesses Utilizing COVID-19 Crowdfunding Program**

More than 100 small businesses across Michigan will utilize the Michigan Economic Development Corporation's (MEDC) MI Local Biz crowdfunding program this month. The MEDC will provide a total of \$500,000 in matching grants to help businesses as they work to recover from the negative economic impacts of COVID-19. The funds must be used for working capital needs in order to maintain ongoing operations during and through the COVID-19 crisis.

# Description and Links to Governor Whitmer's Executive Orders Related to COVID-19:

We are sharing executive orders with you as they are announced. A complete list with links to each of the Executive Orders is available here.

EXECUTIVE ORDER 2020-113 - Continues to allow certain state administrative hearings to be held by video conference or phone through June 30.

EXECUTIVE ORDER 2020-112 - Rescinds Executive Orders on FOIA, hospital capacity, emergency medical services, and loosens restrictions on who can visit patients in certain health settings.

EXECUTIVE ORDER 2020-111 - Requires owners and operators of employer-provided migrant housing to provide residents with the same safeguards businesses are required to provide workers under E.O. 2020-97 and additional requirements.

EXECUTIVE ORDER 2020-110 - Rescinds the Safer at Home order, moves the entire state to Phase 4 of the MI Safe State Plan.

EXECUTIVE ORDER 2020-109 - Extends the face mask requirement, the requirement for grocery stores and pharmacies to provide shopping time for vulnerable populations, and notification of employees when one employee has tested positive for the virus through June 12.
